#### 5. WASTEWATER UPDATE

M. Cowley presented a verbal report and provided a handout that will be included as part of the agenda package. He stated the funds available for the completion of the work being done on the Buck Lake project have been used. He stated that staff will need direction from the committee on the grant application the scope and how much to apply for.

Approve the transfer of up to \$35,000 from the Capital Reserve for the completion of the Buck Lake project.

- Magic Lake Estates Sewerage System Local Service as presented and recommend that the 2018 actual surplus or deficit be balanced on the 2018 transfer to the Capital Reserve Fund; and
- 2. Recommend that the Electoral Area Services Committee recommend that the CRD Board approve the 2019 Operating and Capital Budget and the five year Financial Plan for the Magic Lake Estates Water and Sewer Services as presented.
