BYLAW NO. 4293

A BYLAW TO REPEAL BYLAWS NO. 3030, BEING "FERNWOOD DOCK MANAGEMENT COMMISSION BYLAW, 2002" AND ITS AMENDMENTS AND MAKE CONSEQUENTIAL CHANGES TO BYLAW NO. 3763, "JUAN DE FUCA AND SALT SPRING ISLAND PARKS AND RECREATION ADVISORY COMMISSIONS BYLAW NO.1, 2011"

WHEREAS the Board of the Capital Regional District has, by Order in Council 0100 dated the 24th day of January 1997, been granted the additional power to establish, acquire and operate a service of small craft harbour facilities;

AND WHEREAS the Board owns a harbour facility on Salt Spring Island known as the Fernwood Dock;

AND WHEREAS the Board previously established a harbour commission by Bylaw No. 3030, "Fernwood Dock Management Commission Bylaw No. 1, 2002", as amended;

AND WHEREAS the Board wishes to move the function of advising on the management of Salt Spring Island small craft harbour facilities to the Salt Spring Island Parks and Recreation Committee constituted by Bylaw No. 3763, "Juan de Fuca and Salt Spring Island Parks and Recreation Advisory Commissions Bylaw No. 1, 2011";

NOW THEREFORE the Board of the Capital Regional District in open meeting assembled, enacts as follows:

1. In Bylaw No. 3763, "Juan de Fuca and Salt Spring Island Parks and Recreation Advisory Commissions Bylaw No. 1, 2011", in Schedule B: Salt Spring Island, directly below the definition of "COMMISSION", the following definition is inserted:

"RECREATIONAL FACILITIES" includes Fernwood Dock, Rotary Dock, and any other Salt Spring Island small craft harbours and moorage facilities owned, leased, or licensed by the Capital Regional District.
2. The following bylaws are repealed:
 - (a) Bylaw No. 3030, "Fernwood Dock Management Commission Bylaw, 2002"; and
 - (b) Bylaw No. 3762, "Fernwood Dock Management Commission Bylaw, 2002, Amendment Bylaw No.1, 2011".
3. This Bylaw may be cited as "Juan de Fuca and Salt Spring Island Parks and Recreation Advisory Commissions Bylaw No. 1, 2011, Amendment Bylaw No. 1, 2019".
