
INTEREST-HOLDER ENGAGEMENT

- Community-based, nonprofit presenters and education organizations
- Commercial presenters
- representatives from the Regional Theatres, Juan de Fuca Performing Arts Centre Society (JdFPACS), and IATSE Local 168

COST-BENEFIT ANALYSIS

- Drive time analysis for venue access
- Economic impact analysis of each option / initiative
- > 10-year net present value and social return on investment analysis
- Each option and each initiative analyzed











Status quo problems

All municipalities benefit, except electoral areas

Major capital reserve lacks proven value

Theatre rental grants have high value





STATUS QUO PROBLEMS

- > Frozen funding purchasing power of financial support down 40% since inception of both Royal and McPherson theatre services
- > Complex restrictions on capital funding limits infrastructure renewal
- > Affordability barriers prevent full usage despite high demand





ALL MUNICIPALITIES BENEFIT, EXCEPT ELECTORAL AREAS

- > Drive time: All jurisdictions except the three electoral areas would be within 40 minutes of at least one regional theatre
- Salt Spring Island and Southern Gulf Island Electoral Areas have better access to ArtSpring theatre on Salt Spring Island
- > Electoral areas have lower audience attendance at regional theatres due to population size and geographic limitations





MAJOR CAPITAL RESERVE LACKS PROVEN VALUE

- > Opportunity cost results in negative net present value
- > No current identified project, no plan for spending reserve
- Alternative: loan authorization for capital for new build
- > New facilities are better supported by Planning Grants





THEATRE RENTAL GRANTS HAVE HIGH VALUE

- Strong community support from local arts groups, schools, venues
- > High financial and cultural benefit (multiplier effect)
- > Improved usage rate at theatres, and accrued social benefits:
 - More shows for audiences
 - More access for schools & arts presenters

- Accelerates local arts development
- Contributes to social community health & well-being

DEVELOP

- > NO Major Capital Reserve for large-scale construction or expansion
- > Minor Capital Grants for maintenance and accessibility upgrades to all three regional theatres (Royal, McPherson, Charlie White)

FUND

- Operating Grants to support ongoing operations of all three regional theatres (Royal, McPherson, Charlie White)
- > Theatre Rental Grants to help non-profit community presenters and schools offset theatre rental costs improving access and usage
