## BYLAW NO. 4360

**A BYLAW TO AMEND THE SALT SPRING ISLAND STORMWATER QUALITY MANAGEMENT  
EXTENDED SERVICE ESTABLISHMENT BYLAW NO. 1, 1996**

**WHEREAS:**

- A. Under Bylaw No. 2454, Salt Spring Island Stormwater Quality Management Extended Service Establishment Bylaw No. 1, 1996, the Regional Board has established a bylaw for the control of pollution in stormwater runoff from land;
- B. The Board of the Capital Regional District wishes to amend Bylaw No. 2454 to properly detail and set a maximum requisition for the service;
- C. Pursuant to sections 347 and 349 of the *Local Government Act*, the Electoral Area Director may consent on behalf of the electors to an establishing bylaw amendment;

**NOW THEREFORE**, the Board of the Capital Regional District in open meeting assembled hereby enacts as follows:

- 1. Bylaw No. 2454, Salt Spring Island Stormwater Quality Management Extended Service Establishment Bylaw No. 1, 1996, is hereby amended as follows:
  - (a) by replacing section 4 in its entirety with the following:

**4. Cost Recovery**

The annual costs for the Service may be recovered by the following:

- a) by the requisition of money under Section 385 and 387 of the *Local Government Act* to be collected by a property value tax, based on land and improvements levied and collected under Section 386 and 388 of the *Local Government Act*;
- b) fees and charges imposed under Section 397 of the *Local Government Act*;
- c) revenues raised by other means authorized under the *Local Government Act* or another Act; or
- d) revenues received by agreement, enterprise, gift, grant or otherwise.

- (b) by replacing Section 5 in its entirety with the following:

**5. Maximum Requisition**

In accordance with Section 339 of the *Local Government Act*, the maximum amount that may be requisitioned annually for the cost of the Service is the greater of:

- a) Thirty-four Thousand, Three Hundred and Sixty-Five Dollars (\$34,365); or

- b) a property value tax rate of 0.007805 Dollars per One Thousand Dollars (\$1,000) that, when applied to the net taxable value of land and improvements in the Service Area, will yield the maximum amount that may be requisitioned for the Service.
2. This bylaw may be cited for all purposes as "Salt Spring Island Stormwater Quality Management Extended Service Establishment Bylaw No. 1, 1996, Amendment Bylaw No. 2, 2020".
