The draft plan outlines proposed strategic priorities that are intended to ensure the Regional Water Supply Service is responsive to challenges and opportunities facing the system while maintaining focus on the three long term commitments:



Provide high quality, safe drinkable water



Provide an adequate, reliable, long-term supply of drinkable water



Provide efficient, effective and innovative operations of our water system infrastructure



Strategic Plan Components

The **Mission Statement** lays out our overarching purpose, intention and objectives.

Guiding Principles reflect the current context and the factors we consider when we make decisions about all actions we take.

Commitments are three long-term promises that are foundational to achieving our service mandate. They remain stable across plans.

Each commitment is supported by Priorities and Actions which are reviewed every five to 10 years.






Strategic Plan Development Timeline






Overview of Engagement Process








Rate your level of agreement or disagreement with the statement below: "Historically, the Regional Water Supply Service has met my expectations."





What Do You Value Most


Rank what aspect of the Regional Water Supply Service you value the most.

Reflecting on our current water supply and future water needs, how important is it that the CRD continues to invest in high quality, safe and reliable drinkable water?






Environmental Impacts








Summary

- 91.8% of respondents expressed confidence in the historical performance of the Regional Water Supply Service which aligns with CRD's Regional Resident Experience Survey that showed 92.4% of respondents rated CRD water service delivery as moderately to highly effective
- $\left(\begin{array}{c}2\end{array}\right)$ Strong public support for all commitments
- Strong public support for the direction of the 2025 Strategic Plan in terms of investments in:
 - infrastructure, clean, safe and reliable water
 - watershed management
 - affordability of water rates

Final revisions to the 2025 Regional Water Supply Strategic Plan will incorporate:

Final draft will be presented to the Regional Water Supply Commission for review and approval in the Fall of 2025.
