**NOTICE TO ELECTORS  
WITHIN THE FLORENCE LAKE IMPROVEMENT DISTRICT**

**Alternative Approval Process for Bylaws No. 4393 and 4394  
Florence Lake Water System Local Service Area**

**Notice is hereby given** that the Board of Directors of the Capital Regional District ("CRD") proposes to adopt:

- Bylaw No. 4393, "Florence Lake Water System Local Service Establishment Bylaw No. 1, 2020" to establish a water system local service in the area formerly serviced by Florence Lake Improvement District; and
- Bylaw No. 4394, "Florence Lake Water System Local Service Loan Authorization Bylaw No. 1, 2020" to authorize the borrowing of three hundred thousand dollars (\$300,000) for the Florence Lake water system upgrade.

The intent of Bylaw No. 4393 is to establish a water system local service in the area formerly serviced by Florence Lake Improvement District and requisition annually for the cost of the service. Adoption of Bylaw No. 4394 is also required to authorize the borrowing of \$300,000 over 15 years to fund upgrades to the Florence Lake water system.

**Take further notice** that the CRD may proceed with Bylaws No. 4393 and 4394 unless at least 4 electors within the Florence Lake Improvement District area indicate, by signing the elector response form, that the Board must obtain the assent of the electors by way of an assent vote (referendum) before proceeding to adopt Bylaws No. 4393 and 4394.

The elector response must be in the form as established by the CRD and is available from the CRD on request or from the CRD website. The only persons entitled to sign elector response forms are electors of the area to which the alternative approval process opportunity applies. The Alternative Approval Process opportunity applies to electors within the Florence Lake Improvement District, comprised of properties with an odd-numbered street address ranging between 2601 and 2649 Savory Road, in the City of Langford, BC in the Capital Regional District.

The deadline for delivering the original signed elector response forms, in relation to Bylaws No. 4393 and 4394, to the CRD is **4:00 pm on Monday, July 5, 2021**. Forms must be received by the deadline to be counted.

The CRD has determined that the total number of electors within the service area is 32 and that 10% of that number or 4 electors must submit elector response forms to prevent the CRD from enacting Bylaws No. 4393 and 4394 without the assent of the electors by referendum.

**Qualifications for Resident and Non-Resident Property Electors**

**Resident Elector:** You are entitled to submit an elector response form as a Resident Elector if you are 18 years or older on the date of submission of the elector response form, are a Canadian citizen, have

resided in British Columbia for 6 months and at a property located within the Florence Lake Improvement District in Langford, BC for at least 30 days prior to signing the elector response form.

**Non-Resident Property Elector:** You may submit an elector response form as a Non-Resident Property Elector if you are 18 years or older on the date of submission of the elector response form, are a Canadian citizen, have resided in British Columbia for 6 months, have owned and held registered title to property within the Florence Lake Improvement District in Langford, BC for 30 days and do NOT qualify as a Resident Elector. If there is more than one registered owner of the property (either as joint tenants or tenants in common) only one individual may, with the written consent of the majority, submit an elector response form.
