Public Engagement Report



This report provides a summary of public engagement activities conducted following provisional approval of the 2026 - 2030 Financial Plan on October 29, 2025.

Under the *Local Government Act*, regional districts must adopt, by bylaw, a five-year financial plan by March 31 annually. Section 374 stipulates that a board must undertake a process of public consultation regarding the proposed financial plan before it is adopted. Various CRD commissions and committees receive input leading up to the preparation of budgets in the form of user statistics, surveys, advisory body reports, annual operational reports and from a wide variety of public engagement activities. Local and sub-regional commissions may also include rate payer representatives. This input is augmented by a public feedback period from November 2025 – February 2026, focused on the following objectives:

- Inform residents about the financial planning process and outcomes through digital channels (website, social media) and media coverage.
- Collect public feedback about the provisional financial plan to be shared with the board as part of the final budget review and approval process.
- Correct misconceptions about the service and financial planning process or details of the financial plan.

Engagement Methods

“Get Involved” Website

The CRD uses its digital engagement platform [GetInvolved.crd.bc.ca](https://getinvolved.crd.bc.ca) to share details of the provisional plan, invite feedback, and answer questions. Comments were collected using an online form then forwarded to the Board via the correspondence portal upon receipt. During the feedback period, 3,396 visits resulted in three levels of participation:

- Aware (visited at least one page): 2,053 participants.
- Informed (downloaded documents, visited multiple pages): 1,434 participants.
- Engaged (shared comments or asked questions): 45 participants.

The most popular documents downloaded were the 2026 Preliminary Financial Plan Summary, Capital Projects List and the Committee of the Whole Provisional Budget Package.

Media & Information Updates

An information bulletin was sent to media on November 5, 2025. The bulletin highlighted the preliminary financial plan, next steps and how to share feedback.

Social Media

Staff scheduled a series of posts on social media that provided a snapshot of the budget. Each post included a call to action to learn more on the Get Involved website to drive further audience engagement. Each Facebook post was boosted to increase its reach.

- **Facebook** posts resulted in approximately 399,812 impressions (number of times people saw a post) with a 1.37% engagement rate (percentage of people who clicked, liked, shared or commented).
- **LinkedIn** posts resulted in approximately 7,114 impressions with a 3.91% engagement rate.
- **Instagram** posts resulted in approximately 4,500 impressions with a 1.83% engagement rate.

Video

To support public understanding of the CRD financial planning process, a dedicated explainer video was produced and shared. The video provides a clear overview of how budgets are developed, reviewed, and approved, as well as the sources of funding and opportunities for public input. The following are issues that resonated during this brief review:</p> <ul style="list-style-type: none">• Development of an advanced thermal processing facility at Hartland Landfill to convert biosolids into biochar – Pure biochar is a wonderful resource, particularly for the farming community, in that it not only improves the quality of the soil (nutrient additives) and extends water retention for the area, but also plays a modest role in removing carbon dioxide from the atmosphere.• Regarding Climate Action, the CRD and member municipalities all have an interest in encouraging greater community support for the CRD Climate Action Service.• Support the CRD in becoming a UNESCO Biosphere Region.• A new Regional Transportation Plan (RTP) – Wonderful to see an update to the 2014 RTP. While strengthening and repairing roads and enhancing road connectivity across member municipalities and electoral areas will continue to be important as the CRD population grows, and assuming the growth will be focused on increased densification, (particularly within those progressive municipalities that focus growth in centres, hubs, nodes, villages throughout the region), focusing on transit and active transportation along corridors connecting such centres will greatly facilitate non-single-occupancy-vehicle travel throughout the CRD.• Augmenting 4 km of the Galloping Goose Trail between the Selkirk Trestle and Grange Road (adjacent to McKenzie Avenue), and 2 km of the Lochside Trail between the Switch Bridge and McKenzie Avenue/Borden Street through the Regional Trestles Renewal, Trails Widening and Lighting Project are most welcome. Such enhancements will help to further facilitate active transportation (e.g., walking, running, bicycling, skateboarding) spatially (from Sooke to downtown to Sidney) and temporally (beyond daylight hours). 




