5.1. 19-116 CRD Board Priorities 2019-2022

Mr. Greg Moore facilitated the discussion.

That the Committee of the Whole recommend to the Capital Regional District Board that the CRD Board Priorities 2019-2022 be adopted at the Feb. 13, 2019 meeting with the following amendments:

Have the Corporate Statement on page 5 placed in the document before the Priority Setting cover page;

Find a new Strategic Priority cover picture that reflects identified priorities;

Remove the word "strategic" before "plans" on page 6;

Page 7, under the heading of "Planning and Budgeting" insert the word "measurable" before the word "targets" and try to include "measurable" when referring to targets throughout the document.

On Page 10, add "fiscal and corporate responsibility" to "Advocacy and Governance" in the Desired Outcomes

On page 11, initiative 1a after "cycling" add "and to plan for and deliver a long-term effective regional multi-modal transportation system."

On page 11, initiative 1c after "residents" add "in alignment with our current Regional Growth Strategy";

Change the priority titled "Climate Change Adaptation & Mitigation" to "Climate Action & Environmental Stewardship"

Page 12, combine initiatives 2c and 2d, as follows: "Explore additional opportunities for resource recovery and identify best practices to further reduce waste, increase recycling, and find beneficial uses for waste."

Take 4c from Governance and Advocacy and put on page 12 as a new initiative under Climate Action & Environmental Stewardship.

Page 12, move 2a lower in the list of priorities.

Page 12, amend the vision statement by inserting "protecting and" before "enhancing" and inserting "growth management" after "food security".

Page 12, initiatives 2e and 2f moved for consideration at the Board on Feb. 13, 2019 and that if the Board endorses the recommendations on declaring a climate emergency, these items will be included as initiatives in the Board Priority 2019-2022 document:

Page 14, amend vision statement after "priorities" to say "work collaboratively to address multi-jurisdiction issues that impact the wellbeing of the regions' residents"

Page 14, 4b after "needs" insert "and governance of each of the electoral areas";
Page 14, 4f add "and facilitate a discussion on the region's arts facility needs"
Change review term on page 15 and throughout the document from "biannual" to "annual"

Page 7, under the heading of "Planning and Budgeting" insert the word "measurable" before the word "targets" and try to include "measurable" when referring to targets throughout the document.
