CAPITAL REGIONAL DISTRICT BYLAW NO. 2681

A BYLAW TO ESTABLISH ENFORCEMENT OFFICER POSITIONS AND TO AUTHORIZE ENTRY ON PROPERTY FOR THE PURPOSES OF SECTION 268 SECTION 419 OF THE LOCAL GOVERNMENT ACT AND TO DESIGNATE POSITIONS UNDER SECTION 28 OF THE OFFENCE ACT

WHEREAS:

- A. Section 196Section 233 of the Local Government Act gives the Regional Board of the Capital Regional District the power to establish officer positions and the power to assign powers, duties and functions to those officer positions;
- B. Section 794(5) of the Local Government Act gives tThe Regional Board of the Capital Regional District the authority under section 268Section 419 of the Local Government Act to authorize appointed officers, employees and agents of the Regional District to enter, at all reasonable times, on any property subject to the regulations of the Board, to ascertain whether the regulations or directions are being observed;
- C. Section 28(3) of the Offence Act gives the Regional Board of the Capital Regional District the authority to appoint peace officers for the purpose of serving summonses in respect of an alleged offence under a bylaw of the Regional Board of the Capital Regional District;
- D. It has been deemed necessary by the Regional Board of the Capital Regional District to grant officer status for the purpose of enforcing certain bylaws;
- E. It has been deemed necessary by the Regional Board of the Capital Regional District to grant certain appointed officers, employees and agents of the Regional District the authority under section 268Section 419 of the Local Government Act;
- F. It has been deemed necessary by the Regional Board of the Capital Regional District to grant certain officers the authority to serve summons under Section 28 of the Offence Act.

NOW, THEREFORE, the Board of the Capital Regional District in open meeting assembled enacts as follows:

1. The Offices of Chief Bylaw Enforcement Officer, Bylaw Enforcement Officer, and Assistant Bylaw Enforcement Officer, are established and the person or persons appointed to the positions are authorized to enforce any of the regulations or directions or Bylaws of the Regional Board and are authorized to enter at all reasonable times, on any property, as permitted in section 268Section 419 of the Local Government Act, to ascertain whether any of the regulations or directions or Bylaws of the Regional Board are being observed.

- 2. The Offices of Senior Building Inspector, and Building Inspector are established and the person or persons appointed to the positions, are hereby authorized to enforce the following Bylaws and any subsequent amendments, and are authorized to enter at all reasonable times, on any property, as permitted in section-268Section-419 of the Local Government Act, to ascertain whether the regulations prescribed by the following Bylaws, and any subsequent amendments are being observed:
 - (1) Capital Regional District Bylaw No. 1042 "Building Regulation Bylaw No. 3, 1982";
 - (2) Capital Regional District Bylaw No. 2040 "Sooke Land Use Bylaw, 1992;
 - (3) Capital Regional District Bylaw No. 980 "Langford Zoning Bylaw, 1981";
 - (4) Capital Regional District Bylaw No. 377 "Capital Regional District Mobile Home Parks Bylaw No.1, 1977".
- 3. The Office of Animal Control Officer is established and the person or persons appointed to the position are authorized to enforce the following Bylaw and any subsequent amendments, and are authorized to enter at all reasonable times on any property, to ascertain whether the regulations prescribed by the following Bylaw, and any subsequent amendments are being observed:
 - (1) Capital Regional District Bylaw No.1465 "Animal Regulation and Impounding Bylaw No.1, 1986"
- 4. The Offices of Medical Health Officer, Director of Health Protection and Environmental Programs, Environmental Health Officer, Public Health Educator, and Tobacco Enforcement Officer in the Capital Health Region are established and the person or persons appointed to the positions are hereby authorized to enforce the following Bylaws and any subsequent amendments, and are authorized to enter at all reasonable times, on any property, as permitted in section-268Section-419 of the Local Government Act, to ascertain whether the regulations prescribed by the following Bylaws, and any subsequent amendments are being observed:
 - (1) Capital Regional District Bylaw No. 2401 "Capital Regional District Clean Air Bylaw No. 1, 1996"
 - (2) Capital Regional District Bylaw No. 487 "Tattoo Regulation Bylaw No. 1, 1978"
- 5. "The Office of Watershed Security Officer is established and the person or persons appointed to the position are authorized to enforce the following Bylaws and any subsequent amendments, and are authorized to enter at all reasonable times on any property, to ascertain whether the regulations prescribed by the following Bylaws, and any subsequent amendments are being observed:
 - (1) Capital Regional District Bylaw No. 2804 "Capital Regional District Water Supply Area Regulations Bylaw No. 1, 2000"
 - (2) Capital Regional District Bylaw No. 3682 "Capital Regional District Parks Regulation Bylaw No. 1, 2010"

- 6. The person or persons appointed to the positions of Chief Bylaw Enforcement Officer, Bylaw Enforcement Officer, Assistant Bylaw Enforcement Officer, Animal Control Officer, Senior Building Inspector, Building Inspector, Medical Health Officer, Director of Health Protection and Environmental Programs, Environmental Health Officer, Public Health Educator, and Tobacco Enforcement Officer, and Watershed Security Officer are granted the authority to serve a summons in the manner prescribed in Section 28 of the Offence Act.
- 7. Capital Regional District Bylaw No. 1853, "Capital Regional District Officer and Peace Officer Bylaw, 1990", as amended, is hereby repealed.
- 8. This Bylaw may be cited as the "Capital Regional District Enforcement Officers Bylaw No. 1, 1999".
