

REPORT TO CAPITAL REGIONAL DISTRICT BOARD MEETING OF WEDNESDAY, OCTOBER 11, 2017

SUBJECT Traffic Safety Commission Bylaw Amendment

ISSUE

To consider amending the Traffic Safety Commission (TSC) Bylaw to provide for two additional members.

BACKGROUND

At its meeting of July 12, 2017, the Board of the Capital Regional District (CRD) resolved to add a representative from the Greater Victoria Cycling Coalition and Walk On Victoria as voting members of the TSC.

The proposed amendment bylaw adds the two additional representatives and brings the total number of members of the TSC to the following 19 representatives:

- 1. CRD Director (and alternate)
- 2. ICBC Road Safety Division
- 3. BCAA Community Impact
- 4. Integrated Road Safety Unit
- 5. Youth and Society Research Unit, University of Victoria
- 6. Traffic Planning Sector
- 7. Prevention Services, Vancouver Island Health Authority
- 8. Medical Health Officer, Vancouver Island Health Authority
- 9. Office of the Coroner
- 10. BC Ambulance Service
- 11. School Districts
- 12. Media (2 representatives)
- 13. Vancouver Island Safety Council
- 14. Road Safety BC
- 15. University of Victoria's Centre on Aging
- 16. Commercial Vehicle Safety and Enforcement, Ministry of Transportation and Infrastructure
- 17. A civilian with related experience
- 18. Greater Victoria Cycling Coalition
- 19. Walk On Victoria"

The proposed amendment bylaw is attached as Appendix A. The parent bylaw is attached as Appendix B.

ALTERNATIVES

Alternative 1

Alternative 2

That the matter be referred back to staff for additional information

IMPLICATIONS

There are no financial implications associated with the increase in membership as the new members will volunteer to participate on the Commission. Although the Commission is becoming large, the benefits of including the additional community representatives outweigh the disadvantages associated with having a larger group.

CONCLUSION

The CRD Board has directed that the voting membership of the TSC be increased. The amendment Bylaw adds representatives from the Greater Victoria Cycling Coalition and Walk on Victoria as members of the TSC.
