Achievements

2017 proved to be another strong year for the Victoria International Airport (YYJ). The airport continued to achieve record passenger numbers in each of the first 9 months of 2017

(47 straight record months) and year-end traffic is expected to exceed 1.93 million passengers.

Notable Accomplishments

- Air Canada Rouge introduced new daily wide-body Boeing 767 Toronto-Victoria service. This was YYJ's first scheduled wide-body service in its history.
- Air Canada announced new on-stop Victoria Montreal service to commence June 2018.
- The Air Transport Research Society again named YYJ as being the most financially efficient major airport in Canada.
- VAA fully retired its long-term debt January 2017.
- A commemorative monument, 'The Lost Airmen of the Empire' constructed in 2016 to honour the allied airmen who gave their lives serving at the Pat Bay Air Station in World War II, was officially opened on June 1 with a ceremony of over 400 guests in attendance.
- A new outbound checked baggage system was completed and became fully operational in March featuring new and improved screening equipment to comply with international standards.
- VAA received a development permit application for the Sidney Crossing retail development on airport lands.

Notable Accomplishments – continued

- A \$5.75 million runway overlay project was completed on YYJ's second busiest runway 14/32 to extend the life of the infrastructure a further 20 years.
- A 5,000 m³ litre detention pond was constructed near Reay Creek to mitigate peak surface water flow off airport lands.
- A fourth pre-board screening line was added to address peak congestion at security.
- CNN Travel published its list of the Ten Most Loved Airports in the world, once again naming YYJ as one of their favourites.
- YYJ ranked third overall for the Best Regional Airport in North America for the
 prestigious Airports Council International Award for Airport Service Quality. Since
 2012, YYJ has consistently placed in the top four for North American regional
 airports:



- VAA was recognized by the Saanich Peninsula Chamber of Commerce with a Crystal Award for Business Excellence as 'Newsmaker of the Year'.
- VAA received a Vancouver Island EcoStar Community Environmental Award for 'Ecological Stewardship'.
- YYJ was the Times Colonist Reader's Choice Award winner in the category of 'Way to Get Off the Island'.

Passenger Traffic

Year-to-date passenger traffic was up 4.4% as of October 31, 2017, compared to the same period in 2016, and is forecast to be 1.93 million passengers.

Air Services

- In May 2017, Air Canada Rouge commenced daily wide-body 767 service between Victoria and Toronto. This new service is the first regularly scheduled wide-body service at YYJ.
- Pacific Coastal Airlines continued their significant expansion program at YYJ with the addition of a third daily flight between Kelowna and Victoria, and the addition of new Cranbrook service.
- Air Canada announced new non-stop Victoria Montreal service to commence June 2018.
- Air North announced new Victoria-Whitehorse service to commence May 2018.
- Canada Jetlines announced their schedule intentions should they achieve the required financing, and YYJ is identified.
- WestJet announced the formation of its new ultra-low cost air carrier subsidiary Swoop, to commence service in 2018. While route plans have not been established, preliminary discussions were held regarding Victoria service levels.



Financial Highlights



- The Air Transport Research Society again recognized YYJ as the most financially efficient airport in the country.
- Total revenue before non-cash items for 2017 is expected to be 4.8% higher than 2016.
- Excess revenue over expenses before non-cash items improved 2.9%.
- Long-term debt was fully retired in January 2017.
- 2017 rent to the Federal Government, which is calculated as a percentage of revenue, is forecast to be approximately \$1.67 million. Rent payments have increased 115% over the past five years due entirely to revenue growth.
- In 2017, the VAA paid \$899,000 in property taxes to the District of North Saanich and Town of Sidney.
- Non-aeronautical revenue was 66% of total operations revenue, which represents the highest percentage of the major airports in the country.
- The \$15 Airport Improvement Fee (AIF) remains among the lowest of all of airports in the National Airport System.

Airport Operations

The Operations team is responsible for keeping the runways clear, inspecting and repairing equipment, maintaining the airport grounds and terminal buildings, maintaining VAA's fleet and ensuring compliance with Transport Canada's safety requirements.

- A \$5.75 million project on the airport's second busiest runway was completed. The overlay of Runway 14-32 will ensure safe operations for a further 20 years.
- VAA acquired a \$500,000 sweeper and tractor for runway surface maintenance.
- YYJ experienced one of the most severe winters in recent years but managed to keep the airfield operational the entire period.
- VAA staff actively participated in federal and provincial airport councils to advance policies and procedures concerning airport operations.
- VAA's first female equipment operator was hired on a permanent basis in 2017.



Safety and Security

Safety and security are the highest priorities at YYJ. In 2017 a number of significant initiatives were executed to improve security and safety at the airport.

- A new outbound checked baggage system was opened in March, featuring new and improved screening equipment to comply with international standards.
- As part of YYJ's ongoing emergency preparedness training, in June VAA partnered with WestJet, area first responders and volunteers to simulate a bomb threat in the terminal building. The exercise was a good opportunity to test the airport's Emergency Response Plan.
- The Canadian Air Transport Security Authority (CATSA) and VAA jointly worked on the design and development of a fourth security screening line to facilitate passenger throughput.
- For the third year in a row, VAA participated with Nav Canada to host a workshop designed to educate general aviation pilots, flight training companies and military personnel of safety-related manners of the airport.
- Further improvements to the CCTV camera system were made throughout the year, including expansion in the parking lots and enhancements to the terminal building coverage.
- VAA worked closely with Transport Canada and CATSA to ensure enhanced electronics screening was implemented at minimum disruption to travellers.



Land Development

- VAA resolved a legacy issue concerning height profiles near the airport that has
 constrained development on both the north and east side of the airport. This will
 allow for marketing of new land for both aviation and non-aviation uses.
- The former Department of National Defence 443 Maritime Helicopter Squadron lands and hangar are expected to be turned over to the VAA, which will create opportunities for further aviation development.
- VAA received a development permit application for the Sidney Crossing development which includes a mix of grocery, drug store / pharmaceutical, a fitness facility, financial institution, medical offices and restaurants.
- A high demand prime industrial site on airport lands is to be vacated by Cube Global Storage, which will provide a new development opportunity in 2018.



Environment

YYJ continued to maintain a leadership position with respect to environmental stewardship.



- VAA was the third airport in North America to receive Airport Accreditation status, which is renewed every two years. The last renewal occurred in early 2017.
- The Vancouver Island EcoStar Awards recognized VAA for an Ecological Stewardship award for its remediation work of TenTen Creek.
- A 5,000 m³ litre detention pond adjacent to Reay Creek was constructed to further manage water flows from peak rainfall events.



- The Reay Creek Pond Technical Advisory Committee was formed to discuss potential impacts of downstream pollution.
- Work commenced on TenTen Creek to enhance and 'daylight' an area located near a historical construction waste dump site. The project includes the addition of riparian plantings and other improvements to sections of the creek.



- VAA updated its aviation noise baseline study, which was last updated in 1999. In consultation with the Noise Management Committee, noise monitors were deployed strategically within the community. The results are expected in early 2018.
- VAA renewed BC Hydro's Continuous Optimization Program to reduce energy consumption in the air terminal building.
- A significant amount of English ivy was removed from Dickson Woods on over 500 trees to improve the health of the airport forest.

Donations and Sponsorships

The VAA provided donations and sponsorships toward various charitable causes and community events, which are noted below. In support of the Saanich Peninsula Hospital Foundation's annual gala dinner and fundraising auction, VAA was a table sponsor; the tickets were donated to deserving hospital staff.

The VAA forecasts the 2017 charitable contributions to total approximately \$59,900.

Board of Directors

The Board of Directors provide oversight to the Victoria Airport Authority to ensure its purposes and objectives are realized, and that Victoria International Airport operates in a safe, efficient and reliable manner.

There are twelve members of the VAA Board of Directors. Nine members are nominated by Nominating entities, two are appointed by the Federal government and one is appointed by the Provincial government. The Board has the option to appoint up to three additional directors, at the discretion of the Board. Each director may serve no more than eight years in total.

As a governance board, all Directors are expected to possess a high level of knowledge to advance the fiscal management and governance best practices of the Victoria Airport Authority.

In 2017, the Board of Directors met nine times for Committee and Board discussions. There were three public meetings inviting feedback from stakeholders and the community. The Board also participates in a number of public and private events and fundraisers as positive ambassadors for the airport.

The average attendance at Board and Committee meetings for 2017 was:
