**A BYLAW TO ESTABLISH A CONTRIBUTION SERVICE FOR  
THE SATURNA ISLAND MEDICAL CLINIC**

\*\*\*\*\*

**WHEREAS:**

- A. The Capital Regional District may, under section 332 of the *Local Government Act*, establish and provide any service that the Board considers necessary or desirable for all or part of the Capital Regional District;
- B. The Regional Board of the Capital Regional District wishes to establish a service for the purpose of contributing financially to the administration and operation of the Saturna Island Medical Clinic which is funded by the Saturna Community Club;
- C. Participating area approval is required and assent of the electors has been obtained under Section 344 of the *Local Government Act*;
- D. The approval of the Inspector of Municipalities is required under Section 342(1)(a) of the *Local Government Act*.

**NOW THEREFORE** the Regional Board of the Capital Regional District in open meeting assembled enacts as follows:

**Service**

- 1. The Capital Regional District hereby establishes a service for the purpose of contributing to the costs incurred by the Saturna Community Club in administration and operation of the Saturna Island Medical Clinic.

**Boundaries**

- 2. The boundaries of the Service Area are all of Saturna Island as shown on the map attached hereto as Schedule "A".

**Participating Area**

- 3. The Southern Gulf Islands Electoral Area includes the participating area for the service established under section 1.

**Cost Recovery**

- 4. The annual costs for the Service may be recovered by the following:
  - a) by the requisition of money under Section 385 and 387 of the *Local Government Act* to be collected by a property value tax, based on land and improvements levied and collected under Section 386 and 388 of the *Local Government Act*;

- b) fees and charges imposed under Section 397 of the *Local Government Act*;
- c) revenues raised by other means authorized under the *Local Government Act* or another Act;
- d) revenues received by agreement, enterprise, gift, grant or otherwise.

### Maximum Requisition

5. In accordance with Section 339 (1)(e) of the *Local Government Act*, the maximum amount that may be requisitioned annually for the cost of the Service is the greater of:
- a) Forty Thousand Dollars (\$40,000); or
  - b) An amount equal to the amount that could be raised by a property value tax rate of \$0.17 per One Thousand Dollars (\$1,000) that, when applied to the net taxable value of land and improvements in the Service Area, will yield the maximum amount that may be requisitioned for the Service.

### Agreement

6. A contribution agreement will be established between the Capital Regional District and the Saturna Community Club.

### Citation

7. This Bylaw may be cited as the "Saturna Island Medical Clinic Contribution Service Establishment Bylaw No. 1, 2018".
