The CWF, provided under the Administrative Agreement on the Federal Gas Tax Fund in BC (Gas Tax Agreement), is delivered to all BC local governments through an annual allocation. The CRD's share of CWF is re-allocated to the three Electoral Areas on a per capita basis.

The CRD has been receiving the CWF grant since 2006 under two terms of the Gas Tax Agreement. Table 1 provides a summary of the funding allocation and re-assignment to the Electoral Areas, as well as the number of grants awarded over the period of this report. The CWF specified in the 2014–2024 Gas Tax Agreement has been disbursed to local governments as of December 31, 2018. Future CWF allocations remain unknown.
