Electoral Areas

Strategy

Overview

The CRD has three electoral areas (EA): Juan de Fuca (JdF); Salt Spring Island (SSI); and the Southern Gulf Islands (SGI). An Electoral Area Director is elected every four years by the electors of the area to represent it on the CRD Board.

In each EA, the CRD provides some of the services of a municipal government, such as water, sewage, fire protection, recreation and parks. CRD community planning and land use regulation is provided in the JdF Electoral Area. In the SSI Electoral Area and the SGI Electoral Area, the Islands Trust local trust committees have land use planning authority.

Since its inception, the CRD has established many different commissions to assist with service delivery. At present, there are over 60 commissions that assist with a wide range of services, from fire protection to theatre management. Each CRD commission has a unique purpose and there is wide diversity in operational practice that stems from the role of the commission, its governance structure, its relationship to CRD staff and the service that it helps administer.

Core Service Levels

Building Inspection

 The Building Inspection Division works to provide protection to the residents of the Capital Region for the health, safety, structural integrity, and the fire protection of buildings through the BC Building Code, CRD Building Bylaws, and the *Local Government* Act/Community Chart. Service provided to JdF, SSI and SGI Electoral Areas.

Juan de Fuca Planning

• The JdF EA Community Planning Service develops community plans and implements and administers land use regulations by providing professional advice and recommendations on planning processes and development services, providing for orderly growth, protection of the environment, sustainable communities and resource management.

Salt Spring Island Administration

The SSI EA Administration is responsible for the administration and management of the SSI
Parks and Recreation Commission, Transportation and Transit Commission, Community
Economic Development Commission, Fernwood dock; and in collaboration with other CRD
divisions, eight local water and sewer service areas, and Liquid Waste Management
Commission. The SSI division is also responsible for planning, organizing, and delivering
services for SSI and support to the EA Director through these various service Commissions
and Committees.

Southern Gulf Islands Administration

 The SGI Administration is responsible for the administration and management of service delivery in the SGI in the areas of Community Parks and Recreation, Commission support, the receipt and award of grant funding, and by assisting with the economic development initiatives of the SGI Community Economic Sustainability Commission. The SGI division also provides community planning, organizing and coordination to support the goals of the EA Director.

Juan de Fuca Community Parks and Recreation

• The JdF Parks & Recreation division supports community well-being through the acquisition, development and maintenance of community parks as well as the provision of community recreational programming in the electoral area.

Protective Services

 The Protective Services division protects CRD EA residents by planning for, responding to and recovering from emergencies, providing 911 Call Answer and Fire Dispatch services, supporting EA volunteers emergency programs and fire services, enforcing bylaws and providing animal control service.
