## **SUBJECT** Community Works Fund 2019 Annual Report

## **ISSUE SUMMARY**

This report provides a summary of the Community Works Fund (CWF) grant allocated to the Capital Regional District (CRD) for January 1, 2019 – December 31, 2019.

#### **BACKGROUND**

The CWF is provided under the Administrative Agreement of the Federal Gas Tax Fund in BC (Gas Tax Agreement) with funding amounts based on population. The Union of BC Municipalities (UBCM) administers the CWF to allocate Federal Gas Tax Funding to local governments. The CRD has received the CWF grant under two terms, 2006-2013 and 2014-2024.

The CWF is re-allocated to the three Electoral Areas (EA) on a per capita basis. To distribute CWF funding, the CRD reviews applications throughout the year, and determines whether the proposed project meets eligibility requirements. The EA Directors provide their support to the applications, which are also subject to fund availability.




 Table 4: CWF Awarded by Recipient Type for 2019




