**4.4.** <u>21-808</u> Temporary Modifications to Election Procedures for Assent Voting (COVID-19) - Pender Islands Health Care Centre Referendum

MOVED by Alternate Director Brent, SECONDED by Director Windsor, That the election procedures for the Pender Islands Health Care Centre Referendum be modified as follows:

1. That sections 15.2 and 16.2(a)(i) of Bylaw 3543, "Capital Regional District Election and Voting Procedures Bylaw, 2008" be waived in order to permit mail ballot voting to all eligible electors;

2. That section 125(1)(b) of the Local Government Act be read as though it provided that the person must, as directed by an election official, comply with section 125(1)(b) as written, or make an oral declaration of the facts set out in that section, in which case the election official must make a record that the person made an oral declaration; and

3. That section 125(1)(c) of the Local Government Act be read as though it

provided that the person must, as directed by an election official, comply with section 125(1)(c) as written, or make an oral declaration of the facts set out in that section, in which case the election official must make a record that the person made an oral declaration and of the facts declared. CARRIED
